• Original Color

The Bureau Veritas Certification mark is printed in two colors:

- Pantone 404 C grey,
- Pantone 200 C red.



• Black and white



Dimensions

• Size

The minimum height of the logo is 12 mm (h).

• Protection zone

In order to maintain the visual integrity of the logo, a minimum amount of free space (blank border) must always be respected.



The content

The certification mark will be adapted to name the standard for which you are certified. This is the **ONLY** part of the certification mark that is modifiable with the certificate number. The certification mark can be used with or without reference to the certificate number.

- For a single certification



- For a multiple certification

The certification marks are available in four formats: Jpeg, GIF, EPS and Illustrator.

How and where can you use your certification marks?

The table below summarizes the allowable limits for use of certification marks.

		with a Product Statement*
On product or primary (display or retail) packaging	Not allowed	Not allowed
On larger boxes, etc. used for transportation of products (secondary or transit packaging)	Not allowed	Allowed
On vehicles or permanent structures such as buildings for advertisement	Allowed	Allowed
On brochures, website, in advertising...	Allowed	Allowed
